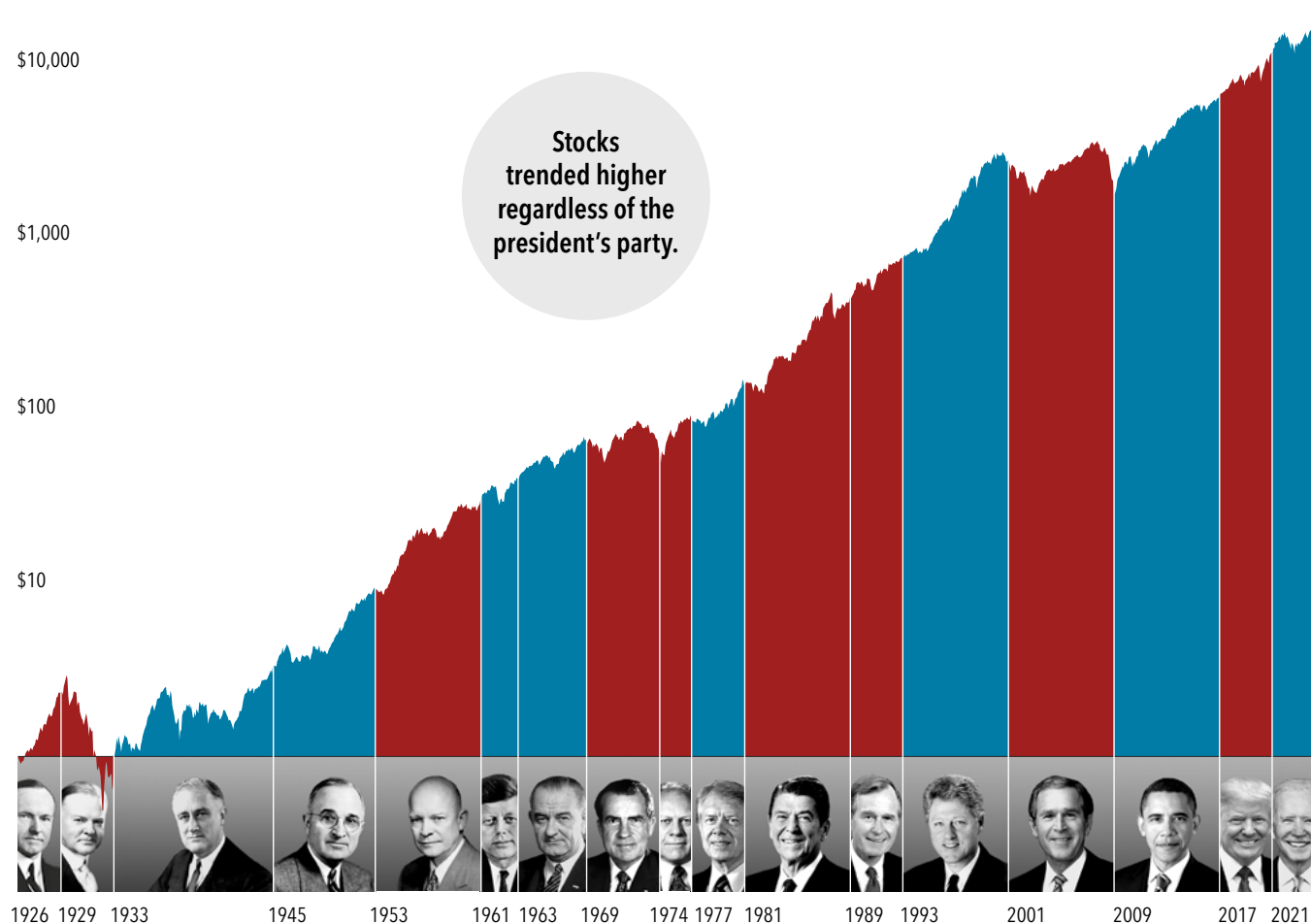


The Market and US Presidential Elections
